

FediBlackBook Standard Software License

I. *Definitions*

- "Research Use" means 'research, evaluation or development' for the purpose of 'advancing knowledge, teaching, learning or customizing' the Technology for academic (educational) non-commercial use. The phrase, and term, 'Research Use' does, expressly, exclude any 'use or distribution' for 'direct or indirect' mercantile (including commercially strategic) 'gain or advantage' of any nature.
- "Licensor" means the FediBlackBook, a 'subject' under the Arrangement for the Jabiyar Delegation to Equatorial Guinea of the Republic of Equatorial Guinea, and its 'successors and assignees' under the provisions of customary international law.
- "Licensee" means You and any other 'person or entity' who/that has entered into this License, by ratification and execution, as a legally-binding document, in perpetuity, under all of the relevant laws (and customs) as per this License.
